

What is included in the Swisscom eDossier?

The Swisscom eDossier basic services in brief:



Basic services

- Document repository: Documents are filed by category via import interfaces and document upload and indexed using OCR for full text search. New versions are created, meta data supplemented and notes added using the user interface.
- Document processing: The file plan centrally defines how a document is processed over multiple levels. The following examples show the simplicity of this feature:
 - Level 0: No validation is necessary and this document type goes straight to the archive.
 - Level 1: A simple correspondence is answered directly in the service desk.
 - Level 2: A customer order is to be handled by two teams in a predefined sequence.
 - Level 3: A new contract has to be handled by multiple teams and released and approved by multiple hierarchical levels. As a user, I always maintain an overview of the team inbox, my cases, my tasks and my personally created dossiers.
- Document archiving: Based on the customer-specific file plan, the
 platform archives the documents in compliance with the law. This
 occurs immediately or when closing contracts or customers depending on the document type. The statutory retention period starts from
 the time of archiving. Once this period runs out, Swisscom ensures
 the documents are deleted in accordance with the law.
- Search and find: The user-friendly web UI and the performance of the platform enable documents and dossiers to be found quickly using meta data or the full text search. Thanks to deep link integration, documents are also found directly in business applications or via web links in emails and browsers.
- Business cases: Documents from different sources and dossiers
 can be assigned to a business case and handled by multiple teams
 in a number of stages. External process-leading applications (case
 management, business process and workflow tools) are easily
 integrated, can trigger business cases in the eCase and are notified
 after completion of document processing.
