## Identify once – sign multiple afterwards Jurisdiction Switzerland and EU

### Smart Registration Service of Swisscom

Swisscom decouples the signature and the identification. Contrary to what is known on the market, Swisscom can use identifications or registrations several times to sign with the Swisscom Signing Service. For this purpose, a person registers at the same time with an authentication means. From now on, only the authentication means for expressing the will is used in the signature process. Depending on the procedure, signatures are possible for months or years after identification.

### Suitable to everyone's situation

You can offer your end customers multiple identifications

- in line with the EU or Switzerland jurisdiction in which the signature has to take place,
- matching the quality of the signature: qualified (QES) or only advanced (FES)
- suitable to the technical possibilities of the end customer.

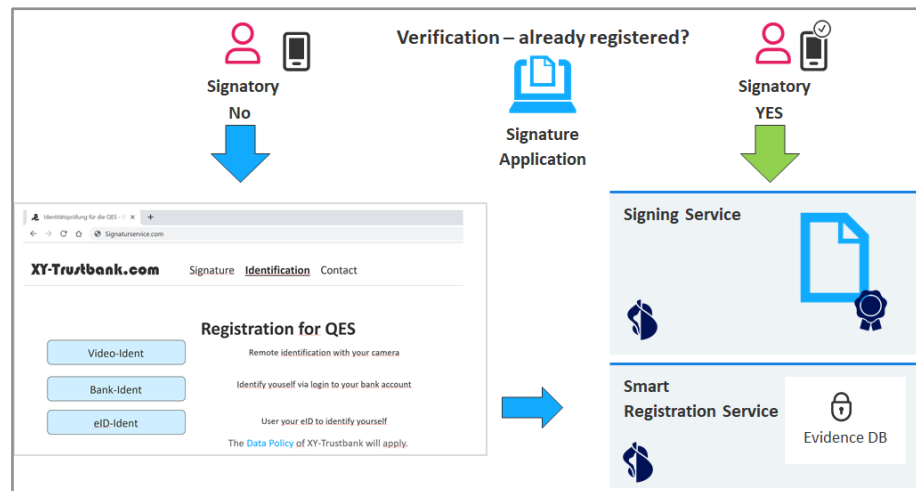
### One-stop purchasing from Swisscom

Swisscom selects its identification partners on the market and registers them as external registration authorities. For example, you can set up a portal and select from several registration methods that Swisscom makes available to you as a catalogue. The catalogue contains the signature conditions (quality of signature, jurisdiction, etc.) for filtering. You or your end-user select a method and your end-user is transferred to the identification partner via a web address provided by Swisscom. The latter imports the evidence records to the registration database of Swisscom. In the context e.g. of anti-money laundering it is even possible to obtain a copy of the evidence data yourself.

### Registration methods






The following methods are available or in planning:

- Video identification QES/FES EU and also FES Switzerland (QES during Corona crisis)
- Bank identification based on German bank account, QES in the EU
- eID of German ID card, QES/FES
- point of sale methods and courier service, QES/FES, (ca. starting in Q4/2020)
