If so, this is the workshop for you. Together, we will lay a solid foundation without going into too much detail.

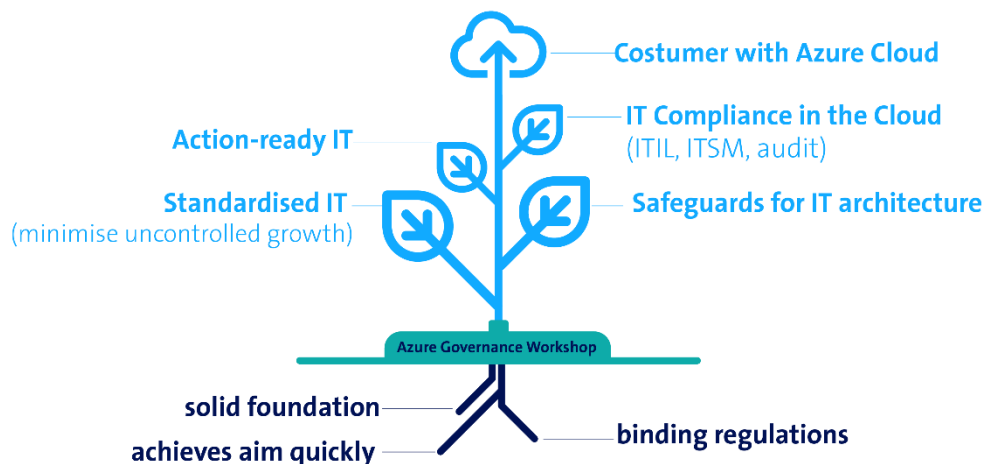

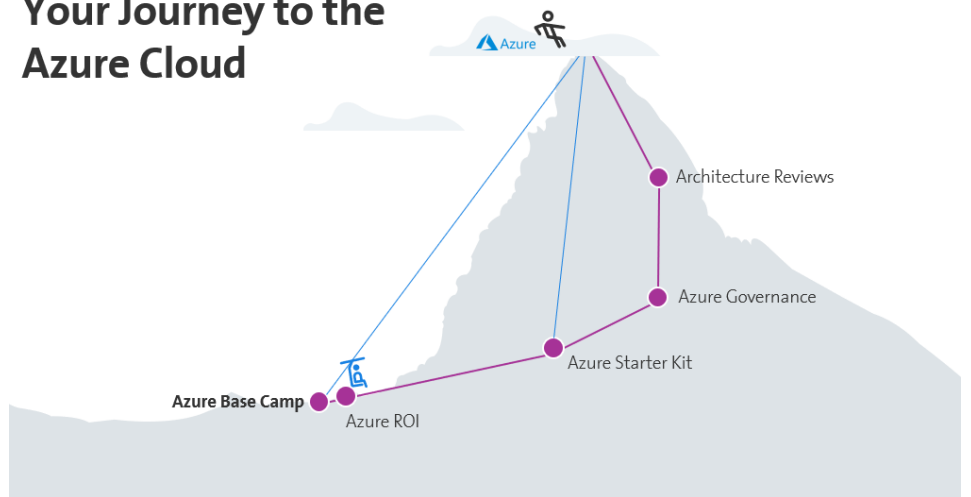
